#### **STEPS FOR THE CANDIDATES**





#### **CANDIDATE LOGIN**

Login into the portal <a href="https://scertpet.co.in">https://scertpet.co.in</a>





## RESULT OF ALLOTMENT OF INSTITUTE

After login check the result of allotment of institute.





#### **ALLOTMENT LETTER**

If selected for admission into an institute, then download the provisional allotment letter.





#### REPORT TO THE INSTITUTE

After downloading the provisional allotment letter, report to the allotted institute within the given dates for document verification & admission.





#### **ADMISSION & FEES PAYMENT**

After document verification & acceptance for admission, pay the admission fees to confirm the seat in the respective institute.





#### **ADMISSION CONFIRMATION**

After the admission process is over, login into the web portal and download the admission confirmation receipt.

## Important steps to be followed by the candidates during admission process:

- a. Allotment of institute: After the declaration of result, the candidates who have appeared in PET-2025 and participated in online counselling will be considered for allotment of institute as per merit & category of the candidate. The allotment will be made against one seat & the allotment of seat will be purely provisional.
- b. If a seat is allotted to a candidate, he/she has to download the provisional allotment letter from the online portal.
- c. If any of the candidates who have been allotted in Government institute will not take admission within the stipulated time then he/she will not be eligible for further rounds of allotment of institute.
- d. The candidates who have been allotted in Private Institute and will not take admission then they are eligible for further rounds of allotment of institute subject to availability of seat and in the next round of allotment of institute his/her preference for that institution will be omitted and other higher preferences will be considered.
- e. In the allotment letter, one undertaking form (Annexure II) will be attached where the candidate will be asked whether he/she wants to participate in next round of allotment of institute or not for better preferred institute as per his/her online counselling. If any selected candidate for admission wants to participate in next round of allotment of institute for better preferred institute as per his/her online counselling, then it means that depending upon his/her merit and vacancy position in institute he/she may be allotted to other better preferred institute as per his/her online counselling. Once he/she is allotted in a new institute after participating in next round of allotment of institute then candidate must report to the newly allotted institute for admission as his/her previous allotment/admission will automatically stand cancelled. If any selected candidate for admission do not want to participate in next round of allotment of institute for better preferred institute as per his/her online counselling, then it means that he/she wish to accept the present allotment and his/her name will be removed from further rounds of allotment of institute.
- f. Candidates who have downloaded the provisional allotment letter, they will have to report to the allotted institute within the given time period with the necessary documents mentioned in **Annexure-I** in original and necessary admission fees.
- g. If a candidate is found ineligible at the time of Physical Document Verification, then his/her candidature will be forfeited from the entire admission process.

### **Annexure-I**

- **A.** All selected candidates will have to produce for verification following documents in original before the Principal of the concerned Teacher Education Institute (TEI) at the time of admission and submit the self-attested photocopies of same along with 1 (one) recent passport size photograph with their signature.
  - i. Certificate for proof of age. (Admit Card or certificate of H.S.L.C. / equivalent examination)
  - ii. Pass Certificate & Mark sheet of Higher Secondary (HS) [10+2]
  - iii. Certificate of Caste (if any) from Competent Authority.
  - iv. Document to proof that he/she is permanent resident of Assam.
  - v. Person with Disability (PWD) & EWS certificate (if any) issued from the Competent Authority.
- **B.** All the selected candidates have to submit an undertaking to the principals of the concerned TEIs with their signature as follows-: ----

"I do here by declared that I have not taken any admission in other regular courses except 2-year Diploma in Elementary Education (D.EI.Ed.) Course for the session 2025-27. The authority may cancel my candidature immediately with disciplinary action if anyone produce evidence of my engagement in any other regular courses or department in the same academic year and in the event of any information/document being found false or not satisfying any of the stipulated eligibility criteria for the course."
